Actions Taken: The nurse evaluated the resident and contacted the APRN. The resident was sent out to FCMC for an X-Ray. The resident?s X-Ray presented the following findings: The visualized bowel gas pattern is unremarkable. Mild constipation noted. No foreign bodies. There is no free air or evidence of obstruction. No pathologic appearing calcification are identified projecting over the kidneys or usual course of the ureters. The osseous structure are intact. The resident has been placed on line of sight and staff will continue to monitor the residents progress in the milieu and school. Guardianship: Private Placement

Interim Action Narrative: Resident evaluated by the nurse and sent to FCMC for x-ray. Resident placed on line of sight.

track. Another resident reported to staff he found two staples and swallowed them. X-ray revealed no foreign bodies.

Licensing Specialist was informed that teachers have been made aware for staples to be kept out of view of the residents. Licensing Specialist was also informed that residents are not allowed behind or around the teachers' desk.

Licensing Specialist and Ms. Coplin discussed how her and the Maintenance Lead complete daily walk-throughs of the facility.
