[REDACTED] then stated that his peer pulled down his pants and allegedly that his peer [REDACTED] forced him ([REDACTED]) to perform oral sex on him ([REDACTED]) in their room. Actions Taken: The nurse evaluated the resident for any signs of injury or complaints of pain. No injuries or complaints were reported. The residents have been reassigned to single room placements, peer restricted to ensure little to no contact and addressed by their assigned clinical therapist to address any trauma both residents have been placed on a sexual safety plan. Nursing and staff will continue to monitor the residents' progress and interactions in the milieu and school. [REDACTED] was made at 3:39pm on 1.4.2023 and [REDACTED] [REDACTED]

Interim Action Narrative: AV resident was assessed by the nurse. Residents were assigned to single room placements, peer restriction, assessed by their clinical therapist, and placed on a sexual safety plan.
