Report Description: [REDACTED] ([REDACTED]-Parent Place), [REDACTED] stated she had a sexual altercation with a staff member (unknown). [REDACTED] stated the staff member followed her into the laundry area and corner her by the counter. [REDACTED] and the staff member exchanged words and kissed, and she slid her pants down, and he placed his finger inside her vagina. [REDACTED] states she does not recall who the staff is, the situation is all a blur, and she does not remember the date the incident occurred. The timeline is around Christmas (not sure if before thanksgiving or after). She reported the incident to supervisor Terrika Harris. [REDACTED]: [REDACTED] [REDACTED]'s mother called the Faulkner County Sheriff's Department, and they came to the facility on Sunday night.

Interim Action Narrative: No interim action needed due to no alleged offender being identified.

Maltreatment Narrative: A resident reported that she was sexually assaulted by a male staff member in the past at the facility in the laundry room. The facility called the [REDACTED] and it was screened out. The Licensing Specialist called the [REDACTED] again and it was accepted for investigation.

Licensing Narrative: Client [REDACTED] reported a sexual assault by a staff member. Client stated the staff member followed her into a laundry area, cornered her by the counter, exchanged words, kissed and staff member placed his finger inside of her vagina. Client states she does not recall who the staff is or the date it happened. The timeframe is around Christmas, not sure if before or after Thanksgiving. Client reported this incident to Supervisor Terrika Harris. [REDACTED] was called, [REDACTED]. Client's mother called the Faulkner County Sherriff's Depts who came to the facility on Sunday 1/8/23. Facility visited 1/10/23 in response to self-report complaint that client [REDACTED] reported that she was sexually assaulted by a staff member. [REDACTED] interviewed. [REDACTED] stated that the staff member who did this was a black male with a goatee in his mid 20's. [REDACTED] was asked if she had seen this person ever again after this incident. [REDACTED] replied "once"..."right after". When asked what if anything was said between this staff and [REDACTED], [REDACTED] quickly replied "He asked 'are we good?'..." "I answered, 'we straight'". [REDACTED] denied that anything physical occurred during this second encounter. When asked if [REDACTED] could provide a name for this staff member, she said she could not. When asked what time of the day this occurred [REDACTED] replied "nighttime"..."it could have been anywhere from 9:30 at night to 4 in the morning". When asked what time of the year this happened [REDACTED] replied, "after Halloween...before Christmas". [REDACTED] had initially reported this to Terrika Harris, a Supervisor at Little Creek. Ms. Harris was interviewed during visit 1/10/23. Ms. Harris stated that [REDACTED] would not provide a description or name of the staff member to her. Jlynn Perkins stated that 4 pictures of current employees had been shown to [REDACTED]. [REDACTED] stated that none of the pictures shown to her were the staff encountered during the incident. Little Creek HR provided the names all males who were employed before Halloween but no longer employed after Christmas. Two names were produced, [REDACTED] (who is now PRN) and [REDACTED] [REDACTED] who resigned in November. Pictures of both of these individuals were shown to client [REDACTED] during today's visit. Client [REDACTED] denied either of the staff pictures were of the staff who assaulted her. No definitive evidence presented 1/10/23 could substantiate allegation. In the event additional information gathered today would assist in this case in the future, the [REDACTED] was called by this Licensing Specialist again in regard to this case. [REDACTED] call, [REDACTED]. 2/1/23- Further information was received and the Program Coordinator reached out to the assigned investigators via email to determine if there has been any progress in the investigation or an alleged offender identified. 5/3/2023- No new information is available on the case and the case has not been closed by the investigator. Licensing will close this case as unfounded 5/3/2023.
