Another peer in the living unit had just completed their nightly chores and the cleaner was accessed on a table in the day area. Poison control was contacted and encouraged an assessment at a medical facility. He was sent to Dallas County Medical Center ER for assessment and assessed/monitored for 6 hours. Otherwise, no treatment was determined necessary. He was released into Millcreek care and placed on 1:1 supervision until 1.16.2023. Suicide assessment conducted on 1.16.2023 and 1:1 was discontinued following the assessment.
