Licensing Specialist completed a walkthrough of EMCC. Licensing Specialist was escorted by Ms. Ashanti, Lead Supervisor. Ms. Ashanti had Mr. Mike, Program Coordinator, on the telephone while escorting Licensing Specialist throughout the building. Licensing Specialist also received a phone call from Ms. Kenleigh, Director of Residential and Clinical Services, while on the premises.

Licensing Specialist observed the following areas: new dorm, treatment hallway, and the classroom. Licensing Specialist did not observe any debris walking into the building. New dorm, there were two (2) residents laying down in the common area due to being on line of sight. The other residents were sleeping, laying down, and two (2) were observed going to the restroom. Ratio 2:6, this is where the girl residents are housed. Classroom, Licensing Specialist observed four (4) residents who appeared sleep. Ratio 1:4, this is where some of the boy residents are housed.

On the treatment hallway, Licensing Specialist observed the conference room, group room, and the VIP room. The conference room, ratio 2:4, the residents were laying down watching television. The group room, ratio 2:4, the residents were laying down watching television. The VIP room, ratio 1:4, the residents were laying down watching television. Majority of the boy residents are housed on the treatment hallway.

There was one (1) resident sitting by staff in the VIP room. The two (2) residents in the new dorm were laying on a mattress separately because they were on line of site. All other residents were laying on their beds on top of their mattresses with covers. Licensing Specialist observed other staff members including a nurse on the treatment hallway completing chores.

Licensing Specialist was informed by Ms. Ashanti that the residents were adjusting well. Ms. Bennett informed Licensing Specialist if things go well with the their insurance, the projected date for repairs is 1/30/2023.
