Licensing Specialist reviewed camera footage on 1/26/2023 for provider reported incident on 1/19/2023. Licensing Specialist received and reviewed nursing notes.

Licensing Specialist observed resident standing at the nurse's station and it appeared having a verbal altercation with a peer. Resident was observed throwing a cup at his peer. The peer was observed attacking the resident. Staff was observed quickly separating the two residents. Licensing Specialist observed the peer taken to the side by staff and the resident was placed inside the nurse's station.

The other residents were escorted off the hall. The peer was taken down the hall by a staff member and once the other residents were off the hall, he was escorted off the hall as well. Resident was observed coming out of the nurse's station. The other residents were observed coming back by the nurse's station for their medication. There was a total of three (3) staff members and a nurse during this time.

When the other residents arrived on the hall, staff was observed keeping the peer and resident separated. Resident (\square) was observed trying to get to his peer. Resident was placed in a restraint, ratio (1:1). Staff stood around the peer to prevent contact with the resident. Peer kept trying to go around staff and was able to kick the resident while he was in a restraint.

Peer was placed in a restraint, ratio (2:1). Other staff members were observed on the hall to assist with the residents. Resident was observed by the nurse and Licensing Specialist observe the nurse on her cell phone after she assessed the resident. Resident was released from his restraint to receive medical attention. Peer was released from his restraint once he had calmed down.

Licensing Specialist and Ms. Lockhart (CEO) discussed the incident. Licensing Specialist was informed that support staff were called to assist with incident. Staff responded quickly and were able to separate the residents. Licensing Specialist did not observe any licensing concerns reviewing camera footage.
