Actions Taken: Resident will be assessed by nursing and any findings will be documented on an incident report. Camera review was conducted with the DHS investigator on 1/30/2023 at 1:48pm. Per camera review, [REDACTED] did not interact with the resident on the day of the allegation. [REDACTED] was assigned to a different group of residents and worked the hours of 7:00am-4:00pm. [REDACTED] has been placed on an Interim Corrective Action plan pending this investigation's findings. Staff and nursing will continue to monitor the residents' progress while in school and on the milieu. Guardianship: Private Placement

Interim Action Narrative: Staff ([REDACTED]) was placed on an ICA that has been approved. Staff will not have any direct contact with the residents until investigation is completed. Resident was assessed by nursing.

Licensing Specialist received a complaint on 1/30/2023 regarding a resident and staff member. Licensing Specialist reviewed camera footage and interviewed the resident.

Licensing Specialist observed resident enter his hallway and go into his bedroom. Licensing Specialist did not observe any staff member push/shove resident into his room on the reviewed camera footage. Licensing Specialist observed other residents walk up and down the hallway with staff members walking up and down the hallway and in and out of the bedrooms. Licensing Specialist was informed that residents were getting ready to go to school. The staff members that were observed on the camera footage were Ms. Barnett and Ms. Gabby, ratio 2:12.

Licensing Specialist interviewed resident on the 300 Hall in a room for privacy. Resident informed Licensing Specialist that the incident happened on the weekend but could not provide a specific timeframe. Resident reported that staff member [REDACTED] told him to get out of the doorway and she touched, pushed, shoved his shoulder. Resident reported to Licensing Specialist all three (3) words and stated that staff scratched him on his hands. Licensing Specialist observed any scars on resident's hands. Resident stated that staff member [REDACTED] has called him and other residents "idiots and retarded."

Licensing Specialist spoke with Ms. Helena, Director of Quality and Risk Management regarding the complaint. Licensing is not prepared to leave a finding at this time.
