The resident returned to the facility with a diagnosis of:

. The resident was placed on peer restriction from the resident he was in a physical altercation with. The resident was also placed on assault precautions for initiating the fight. Licensing Specialist reviewed camera footage on 2/6/2023 for provider reported incident that happened on 2/3/2023. Ratio was 3:14.

Licensing Specialist observed some residents playing basketball with staff. Licensing Specialist observed some residents sitting on the bench, a staff member standing by a bench, and another staff member at the doorway of the gym.

Licensing Specialist observed resident, and a peer go up for what appeared to be a layup and there was a slight tussle over the basketball. It appeared that words were exchanged, and resident shoved peer. Licensing Specialist observed staff going toward the basketball goal where the two residents were being physical with each other. Licensing Specialist observed staff pointing toward the doorway of the gym. The residents were separated by staff and the peer walked out the doorway of the gym.

Licensing Specialist then observed resident attempting to be physical with his peers that remained in the gym. Staff intervened and the resident was separated from his peers. Licensing Specialist observed the peer from the first incident enter back into the gym. Staff was observed blocking peer from getting to the resident.

Licensing Specialist observed resident being assessed by a female staff member and escorted out the gym. Staff intervened to the physical altercation and other attempts.

Licensing Specialist and Ms. Coplin discussed the incident. Due to resident initiating the physical altercation he was placed on assault precaution and peer restriction.
