At 3:01pm, a peer gave the Client ([REDACTED]) a sharp piece of plastic. Staff member ([REDACTED]) put the Client ([REDACTED]) in an improper restraint while trying to retrieve the object. The Client received a minor injury to his finger. Client received a bandage for it. No outside medical treatment was necessary. The staff member is asked to leave the facility after camera footage was reviewed. Hotline was completed.

Interim Action Narrative: Resident was assessed and received a bandage for his injured finger. Staff member was asked to leave the facility after camera review. [REDACTED] called.

Ms. Banks informed Licensing Specialist that she was informed by the CEO to keep things simple but would provide more details when reporting to the [REDACTED]. Licensing Specialist requested nursing notes. Licensing Specialist reached out to Investigator Cunningham. Licensing Specialist received a copy of the facility's policy regarding emergency safety interventions. 2/15/2023, Licensing Specialist inquired about witness statements. Licensing Specialist received a witness statement. 2/16/2023, Licensing Specialist received another witness statement. 3/8/2023, Licensing Specialist emailed Investigator Cunningham for an update. Licensing Specialist informed that case is still pending. 3/22/2023, Licensing Specialist emailed Investigator Cunningham for an update. 


