While chewing them the resident stated he accidentally swallowed them. Actions Taken: Resident was assessed by nursing and APRN then sent out to FCMC for further evaluation. The resident returned to the facility with a diagnosis:
. Continued follow-up is recommended. There is no free air or evidence of obstruction. The resident will continue follow up X-rays until the staples have exited the body. The staples have descended from the body as of 2/18/2023. The resident was placed on line of sight precautions while in the milieu and school. The resident will remain on line of sight until deemed safe by his assigned therapist. Guardianship:
Interim Action Narrative: Resident was assessed by nursing and sent to FCMC for further evaluation. He was placed on line of sight precautions. Staples descended from resident's body on 2/18/2023.
Maltreatment Narrative:

Licensing Narrative:Licensing Specialist reviewed provider reported incident and will follow-up with facility. Licensing Specialist informed that resident found the staples in the wall. Resident removed the staples from art work that was hanging inside of the classroom. Licensing Specialist also informed that teachers have been instructed to use alternative items for hanging art work in the school. Licensing Specialist will schedule a walk through of the school. 2/27/2023, Licensing Specialist completed walkthrough of the classrooms.
