Unannounced visit to facility today.

Viewed all units-blue, orange, and green. Bedrooms in blue unit were clean and no contraband or dangerous materials were observed at time of visit. Bedrooms in orange unit were clean and no contraband/dangerous materials observed at time of visit. Ratio on green unit was 1:2--2 residents refusing school were in bed. Residents' rooms were on opposite ends of the hall, and MHT was in the dayroom. Licensing specialist viewed MHT Q15s to verify supervision in accordance with regulatory requirements--Q15s were completed/current for both residents. Licensing specialist verified that neither resident was on a constant LOS safety plan. Unit was clean and no dangerous items were identified.

2nd Classroom 3:14

Cafeteria: 2:3--2 MHTs were at a table working on schoolwork with 3 residents who were experiencing behavioral issues in the classroom.

Viewed grounds--no safety hazards identified. Grounds are now open for use as the roofing project has been completed.
