Small circular breaks in the skin noted from resident picking at skin with fingernails. Redness with minimal bleeding noted. No first aid required. No redness on neck noted. Crisis interventionist and therapist brought in for support. was eventually able to self-regulate and processed 1:1 with DON/ADON and returned to unit without further incident. Resident agreed to take AM medications. C-SSRS scale preformed, resident scores high risk for suicide. Suicide and self-harm precautions now in place. Resident placed in paper scrubs for safety. Will continue to assess with C-SSRS scale once per shift.

Interim Action Narrative: Redness with minimal bleeding noted, no first aid required. Crisis interventionist and therapist were brought in for support. Resident was able to self-regulate and processed 1:1 with DON and ADON. Resident returned to her unit without further incident. S
