The resident then ran through the school, kicked open several doors and exited through the front lobby. Actions Taken: Staff followed the resident and attempted to process with them until he was off the premises. Once the resident is off the premises staff are not permitted to follow. FCPD was contacted at 11:42am. The resident returned to the facility on his own at 11:55am. The resident was assessed by nursing, there were no visible or complaints of injury. The resident has been placed on unit restriction and elopement precautions, which will be re-evaluated in the next 72 hours for safety. Guardianship: AR
