Yesterday 11/16/2022 around 08:47pm, resident pushed past staff while they were attempting to close the door to the unit. While on the milieu, resident began yelling and threatening to attack a staff member that she had a verbal disagreement with earlier in the day. Resident was threatening to attack any peer that came off the unit for med pass. She attempted to attack a staff member several times and ended up spitting on the staff member. Resident jumped on top of the nurse?s station and began throwing binders and papers. She jumped off the counter and grabbed the phone and dialed 911 stating she ?wants to go to jail.? Because the call was connected before phone was removed from resident for safety, Springdale Police was dispatched to the facility. Once at the facility, police officers were taken to milieu where they observed resident banging on the window of the door and making several verbal threats to staff/peers. Resident attempted to push past police and was placed in cuffs to maintain safety. She continued to make verbal threats to police and staff. After several minutes, resident was able to calm down and discuss the events that took place with police/staff. Handcuffs were removed by police once resident showed safe behaviors. Minimal redness noted on wrists. No first aid required. Will reassess in the AM. Resident was not arrested or charged with any crime. She will remain at the facility at this time. She took her PM medication and went to her unit where she fell asleep without any further incidents. I will be extending her current assault precaution safety plan for an additional 7 days for spitting at staff and making several verbal threats.
