(for previous attempts and safety precautions) . When staff approached to do a safety check
[REDACTED] had 2 socks tied together and was making gestures to put it around their neck. [REDACTED]
would not disclose why they did this. [REDACTED] also refused all PM medications, also no
disclosing why. Suicide precautions have been extended.

Interim Action Narrative: Resident was placed on suicide risk and constant line of sight for
7 days. Staff removed the socks from the resident and she was assessed by nursing.
