Report Description: During an individual therapy session with MHP, patient [REDACTED] ([REDACTED], [REDACTED] DCFS Custody, DOB: [REDACTED]) reported that patient [REDACTED] ([REDACTED], Arkansas, Parent custody, DOB: [REDACTED]) entered the laundry room, turned off the light, and stated that [REDACTED] nte was going to rape him ([REDACTED]). [REDACTED] stated that he yelled, and that [REDACTED] was "feeling" on him. Staff came to door and both patients exited the door. [REDACTED] refused to complete a witness statement. During session [REDACTED] was asked about the allegation of sexual misconduct. [REDACTED] admitted to entering room, turning off the light, and locking the door.
