taken to the Juvenile Detention Center. Facility had to get approval from Texas DHS for resident to return to the facility. Once approval was granted, the facility went and picked up the resident from the Juvenile Detention Center.

Once the alarm was pulled [REDACTED] ran out of the facility through the back door. She was able to enter the employee breakroom and steal car keys and the wallet of a staff member. She then fled facility grounds in the staff members car and her wallet. Immediately the police were notified.

Interim Action Narrative: The police were called. Resident was picked up by the Conway Police Department. She did not return to the facility. AR DHS picked up resident from Conway's Juvenile Detention Center.
