Report Description: 11.26.22 at 0922: [REDACTED] (Nevada, Parent Custody, DOB: [REDACTED]) was engaged in a physical confrontation with [REDACTED] ([REDACTED]), DHS Custody, DOB: [REDACTED]). [REDACTED] and a group of peers took and refused to return a soda bottle that belonged to a staff member. The bottle was dropped by the other patients. [REDACTED] picked up the bottle and returned it to the staff. [REDACTED] approached [REDACTED] and punched him three times in the right eye for returning the bottle. Nurse assessment revealed swelling and bruising to right eye. PERRLA. Neuro within normal limits. Patient denies vision difficulties. 11.26.2022 at 1700: Nurse assessment reveals that the right eye was swollen shut and that [REDACTED] had vomited. Referred to Dallas Co. Medical Center ER for evaluation. Assessment revealed a fracture to the right occipital lobe. He was referred to AR Childrens for assessment. 11.26.2022 at 2155 was transported by facility staff to AR Children's for assessment and released with a referral for follow-up with an ENT specialist.
