The facility was made aware that this incident will be reviewed, and further discussion would occur in the near future as this was a failure to comply with the current Corrective Action Agreement. 12/29/22- Licensing visited the facility and again discussed

that all incidents of self-harm must be reported to the licensing unit by the next business day as part of their current corrective action agreement.
