Actions Taken: The nurse evaluated the resident. The resident did not have any visible or complaints of injury. ██████████ has been assigned a single room placement and peer restrictions to ensure limited to no contact with ██████████. Both residents have been seen by their assigned therapist to address any trauma or concerns. Nursing and staff will continue to monitor the residents' interactions with their peers while in school and on the milieu. A camera review was conducted on 12/14/22 at 2:06pm, there is no footage due to the misconduct happening inside of their rooms.

Interim Action Narrative: Resident was evaluated by the nurse. ██████████ was assigned to a single room and peer restriction. Both residents were seen by their assigned therapist.
