Report Description: When performing a patient check, a staff member discovered [REDACTED] (Nebraska, Parent Custody, DOB: [REDACTED]) after an incident of self-injurious behavior. She was noted to have a 3-inch laceration on her left forearm in addition to other superficial scratches. The wounds were cleansed and covered by on-site nursing. She was referred to Dallas County Medical Center ER for treatment. She received 4 sutures on her left lower forearm and was released to return to the facility.

Interim Action Narrative: Entire cottage has been searched to ensure that children's personal items cant be used to inflict self-injury shall not be left in the child's room unless the dangerous component has been removed.

answers as follows: incident occurred on 12/19/22 @ 1839, it occurred in a patient bedroom on the Flamingo Hall, the resident used a broken glass bottle of nail polish, and there is video available for licensing to review. Client is a new admit and was on Close observation and elopement precaution for the first 30 days. After this incident, she was placed on unit restriction for 72 hours. Facility visited 12/29/22 and cited 910.1.
