The Guardian has not answered the phone for the past 2 days with several incidents with this resident.

**Narrative:**

Program Coordinator and Licensing Specialist Sutton visited the facility to discuss an incident that occurred on 12/25/22 regarding resident [REDACTED] obtaining a razor and using it to self-harm.

Licensing and the facility DON discussed how the resident was able to obtain a razor. The DON Ana Salazar reported that the residents were having a "Make Up" day on the unit. The staff brought in their own makeup from outside the facility for the residents and an eyebrow razor was in the bag. The resident took the razor and disassembled it to use the razor to self-harm. Ms. Salazar reported that the staff are no longer allowed to bring in outside makeup to be used on the residents and moving forward "Make Up" days will only be allowed for residents on a certain treatment level as a reward. The facility will then purchase that make up for the resident as to ensure no cross contamination occurs with sharing makeup.

The facility will be cited for 907.2 and 910.1 as the staff failed to provide appropriate supervision to this resident who had already self-harmed two other times earlier the same day and was on active self-harm precautions. Any items being brought onto the unit from outside the facility should be searched thoroughly for any potential hazardous items.
