The resident complained of pain to the L cheek area with swelling and bruising. LT temple area presented with bruising and abrasions. Actions Taken: The nurse evaluated the resident. The resident was sent out to FCMC for further evaluation; he was diagnosed with the following:

Resident was placed on assault precautions and peer restrictions to ensure little to no contact between the residents. Precautions will be reassessed in 72 hours. Nursing and staff will continue to monitor the residents' progress while in the milieu. Guardianship: Private Placement

Interim Action Narrative: Resident was assessed by the nurse and evaluated further at FCMC. Diagnosis: contusion of an unspecified part of head. Resident placed on assault precautions and peer restrictions to ensure little to no contact between residents.

When residents were brought back into the group, resident was attacked by his peer and they became physical with each other. Staff broke up the altercation and separated the residents. Camera footage is available. 1/6/2023, Licensing Specialist reviewed camera footage of incident that took place outside the gym and on the courtyard. Staff were in ratio 2:12. No licensing concerns were observed during the camera review.

Licensing Specialist viewed camera footage on 1/6/2023 for incident on 12/31/2022. It was reported that resident was in a physical altercation with a peer and complained of left cheek pain with swelling and bruising.

Licensing Specialist observed ratios of 1:6 and 1:6. Residents were leaving the gym and the other residents had already left the gym. Licensing Specialist observed the resident what appeared trying to approach his peer. The peer was observed walking away from the resident. The resident was observed running by staff to get to his peer. The peer ran in the opposite direction with the resident following. Staff was observed running after the resident.

Due to the angle of the camera, Licensing Specialist was unable to view the altercation on the courtyard. Licensing Specialist did observe both staff members at the location of the altercation. Each staff had a resident, and they were separated.

Licensing Specialist did not observe any licensing concerns on the camera footage. Staff were in ratio, 2:12.
