Licensing Specialist completed a buildings and grounds walkthrough. Licensing Specialist was escorted by Ms. Summer, Director of Quality and Risk Management. Licensing Specialist observed the following areas: courtyards, gym, butterfly room, comfort room, blue rooms, classrooms, and Unit 4.

The butterfly room had a resident on line of sight, ratio 1:1. Two (2) courtyards were observed where the residents go for recreational therapy. Courtyards were clean with no debris. Licensing Specialist observed picnic table and benches on both courtyards. In the gym there were acute residents, ratio 2:9.

There were two (2) residents in the day room of Unit 4, ratio 1:2. On Unit 4, Licensing Specialist observed bedrooms B129, B130, B132, and B134. Bedrooms B129 and B130 including the bathrooms were clean with no debris. Bedroom B132, housekeeping was cleaning when Licensing Specialist was on the unit. Bedroom B134, there was a resident having a crisis.

Licensing Specialist observed the laundry room, comfort room, and blue rooms. All rooms were clean and free of debris. The blue rooms are timeout/seclusion rooms. Classrooms E115 and E114 were empty but there was a teacher in E115. Classroom E113 had residents, Licensing Specialist observed a ratio of 1:5.
