Licensing Specialist completed a buildings and grounds walkthrough of Mabee, Rose, Chestnut, and Sturgis houses. Licensing Specialist was escorted by Mr. Jon Pulliam, Lead Unit Manager. Licensing Specialist observed the following areas: bedrooms, bathrooms, laundry rooms, milieus, comfort rooms, seclusion rooms, kitchen areas, the grounds around the houses, and group rooms. All grounds around the houses were clean with no debris.

Mabee House (girls): all bedrooms were organized with no debris and bathrooms were clean. There was a chair in the milieu that was worn out in the seat. Mr. Pulliam requested to have the chair removed. All other rooms of the house were clean, organized, and free of debris. Residents were in school during Licensing Specialist walkthrough.

Sturgis House (boys): Ratio 1:1. Residents were at school when Licensing Specialist completed the walkthrough. Bathrooms were clean and free of debris. All bedrooms were organized, beds were either made up or had folded bedding at the foot of the bed. Licensing Specialist observed a water fountain for the residents to have drinking water. Licensing Specialist observed laundry in the milieu that was being folded.

Chestnut House (boys): Children rights were observed on the wall by the milieu. The comfort room, seclusion room, day area, game room, and milieu were clean and free of debris. All bathrooms were cleaned. Licensing Specialist observed all bedrooms. The bedrooms were cleaned and organized.

Rose House (girls): Ratio 1:1, other residents were at school. Licensing Specialist observed the following rooms: laundry room, seclusion room, and comfort room. All bedrooms and bathrooms were clean, and organized. Licensing Specialist observed contractors rebuilding/renovating the pavilion between the Rose and Mabee houses.

Licensing Specialist and Mr. Pulliam discussed the chair at Mabee House that was worn out in the seat area. Mr. Pulliam requested for the chair to be removed.
