Approximately 4cm. Denies pain. No breaks in skin. When interviewed by Risk Management Department, he stated that he was being self-injurious and he felt that was not trying to harm him. When asked what led up to this stated, "I bang my head on the wall". When asked why was banging his head on the wall "I've just done that since I was 2". When asked if there were any indicated that his roommate left before this happened. When asked if he was witnesses to this playing a video game prior to this incident indicated that he was, but then went to his room. was asked if put him in his room or he went on his own indicated he didn't remember. was asked again what led to a bruise on his hip at which point replied "I don't" know".

Licensing is not prepared to make a finding at this time. Risk Mgmt., Chris Butler reports that staff will be in-service retrained in TCI following this incident.

Follow up email with facility reports: 'statement of redirecting away from the wall by guiding him by his left hand and left shoulder agrees with statements made by ) when they were initially interviewed by Risk Management.

The nurse who assessed the patient stated that the bruise was on his right flank (side).

The report of the allegation was made after had an on-campus visit with his mother. She saw the bruise and asked him where he got it. Upon returning to the nursing station to check him back in, she told to show the bruise to the nurse and report the story of how he got it.
