Incident Description: Resident [redacted] tied a hair tie around [redacted] hand attempted to cut off circulation. Staff removed hair tie and [redacted] was placed on a safety plan. [redacted] then tried to tie a shirt around [redacted] neck. Staff intervened and removed the shirt to prevent self-harm. [redacted] became physically and verbally aggressive toward staff. Order restraints by Dr. Froman. While in containment [redacted] continued to be verbally aggressive and threatened staff. Police were called and charges filed.

Agency’s Interim Corrective Action: Staff intervened to protect staff, resident, and peers. Hair tie and shirt removed immediately. Dr. Froman notified when [redacted] was unable to self-regulate. Order of restraint by Dr. Froman at 2210. [redacted] placed in physical containment from 2210 to 2240. Police called, [redacted] transported to JDC by police officials, and charges filed. [redacted] charged with Second Degree Battery.
