Incident Description: Resident itied a hair tie around hand attempted to cut off circulation. Staff removed hair tie and was placed on a safety plan. hand attempted to cut off circulation. neck. Staff intervened and removed the shirt to prevent self-harm. became physically and verbally aggressive toward staff. Order restraints by Dr. Froman. While in containment continued to be verbally aggressive and threatened staff. Police were called and charges filed.

Agency's Interim Corrective Action: Staff intervened to protect staff, resident, and peers. Hair tie and shirt removed immediatley. Dr. Froman notifed when was unable to sefl-regulate. Order of restaint by Dr. Froman at 2210. placed in physical containment from 2210 to 2240. Police called, transported to JDC by police officials, and charges filed. charged with Second Degree Battery.
