Camera footage review indicates that the camera in the YCC office was partially blocked by prior to the time indicated. Camera footage did show resident in the office during time period. |
| Interim Action Narrative: Staff member already had been sent home on suspension pending investigation. Staff member was terminated on 8/18/2022 due to violating standard operation procedures. |

Narrative: Licensing Specialist received a complaint on 8/18/2022 that a resident was involved in a maltreatment case involving a staff member. Specialist reviewed camera footage on 8/22/2022 and viewed staff and resident walking around to different locations (hallway, cafeteria, kitchen, and YCC office) of the facility. Licensing Specialist inquired about the corrective action plan moving forward. The CEO, Michael Hinton informed specialist moving forward:

- •They will go from viewing camera footage from 2 hours to 4 hours a week.
- •No one will begin on an unit until all background checks have been completed.
- •Looking into being able to move cameras around.
- •Residents and staff members are not allowed 1:1 into those areas mentioned.
- •Only Lead MHT's will have keys to the cafeteria

The facility reports that staff member (was terminated from employment on 8/18/2022 due to violating standard operation procedures.
