Client ([REDACTED]) told Amanda, " On August 26, 2022, he was making noise and the staff member ([REDACTED]) was rude with him. Therefore, [REDACTED] threw socks at the staff member ([REDACTED]). The staff member [REDACTED] ran into his room and kicked the client [REDACTED] in the back. After the client [REDACTED] got on the bed, the staff member [REDACTED] started hitting him. [REDACTED] put his foot out where so she could not hit him anymore. The staff member [REDACTED] left the room and came back into the room to put [REDACTED] in a hold. Licensing Narrative: Licensing Specialist viewed camera footage of the incident that happened on 8/26/2022. The following areas were viewed Big Boys Hallway, Big Boys Bathroom, and Big Boys Hall Entrance. Specialist observed BI [REDACTED] kick her leg toward a resident on the Big Boys Hallway at 7:26 pm. At 8:14 pm a resident threw socks and other items at staff [REDACTED]). Staff threw the socks back in the resident's bedroom. 8:15 pm resident threw shoes at staff and staff threw the shoes down the hallway. Resident [REDACTED] pushed staff and was confrontational. 8:17 pm staff was observed entering into the bedroom. It was reported that resident previously threatened to get staff fired. Specialist observed another staff member intervening as confrontation went back and forth. Staff ([REDACTED] was observed going in and out of the resident's bedroom. Other residents were observed watching and/or instigating the situation. Specialist was unable to observe what took place in the bedroom. However, Specialist observed the tension between the staff and resident.

Narrative: Licensing Specialist received a complaint on 8/31/2022 that a resident reported that he was attacked by staff ( [REDACTED] ) for making noises. Specialist viewed camera footage and observed BI ( [REDACTED] ) kicking motion toward a resident. Specialist also observed a resident threw socks and other items into the hallway at staff. Staff ( [REDACTED] ) threw the socks and other items back into the resident's bedroom. When the shoes were thrown, staff threw the shoes down the hallway. Resident came out of his bedroom, pushed, and confronted staff. It was observed staff and resident going back and forth verbally with the staff member going in and out of the resident's bedroom on different occasions. The ratio was 6:2, another staff intervened by talking with the residents including the onlookers and instigators. Tension was observed on camera footage between the staff member and resident.

It is unknown to specialist what took place in the bedroom due to no cameras in the bedroom. Specialist was informed that the resident is no longer at the facility and the staff is on suspension.

Licensing is not prepared to leave a finding at this time.
