The resident expressed that he was still angry because the staff hit him. Camera observation was conducted at 2:15pm by the CEO, Quality Risk Director, Program Director, and Human Resource Director. Per camera review while going into the containment staff member ([REDACTED]) is observed hitting the resident with a closed fist multiple times in the head area. Actions Taken: The staff member [REDACTED] has been terminated as of 9/12/2022 2:46pm. [REDACTED]

The resident was assessed by nursing no redness or discoloration at the times. The resident reported it to the nurse that he was hit in the eye by staff. Nursing will look at his eye later in the evening to identify any changes. All proper notifications were completed.

Licensing Specialist followed-up with Investigator Harris on 10/24/2022 and was informed that she was working on the report. 11/4/2022, Licensing Specialist emailed Investigator Harris. 11/7/2022, Investigator Harris informed Licensing Specialist case closed and found TRUE. No more licensing concerns noted.
