Report Description: AV is foster child [REDACTED] AO is [REDACTED], last name, and age unknown. [REDACTED] was staying at Centers for Youth and Families when incidents of alleged CMS-S occurred. It was reported that two weeks ago AO "[REDACTED]" told [REDACTED] that he wanted to take her to his home and "make her have his babies." He then attempted to force her into the "hygiene closet" to have sex with her. The reporter suggested that while trying to force her into the closet, [REDACTED] "touched her butt." [REDACTED] resisted and [REDACTED] hit her with his right hand, open handed, on the back of the head. No other contact took place. [REDACTED] reportedly would continually make comments about "meeting outside to take her to his home."

Interim Action Narrative: Staff placed on administrative leave pending the results of the investigation.

Maltreatment Narrative: Ref# [REDACTED]. AV is foster child [REDACTED]. AO is [REDACTED] last name, and age unknown.
