[REDACTED] stated that the [REDACTED] held her in the corner with one hand on her chest. [REDACTED] stated that the [REDACTED] touched her genitals over the clothes and under the clothes. [REDACTED] asked [REDACTED] to stop but reported that the [REDACTED] said, "I'm not going to stop?". [REDACTED] was assessed for injury and she reported pain and tenderness around the perineum between the labia. The resident reported pain 6 out of 10. The resident was provided a prn pain medication.
