Report Description: At The Center's Elizabeth Mitchell Adolescent Center, the orders that are given by the doctor are not being followed. There are two clients that are on a 6-foot order due to sexual allegations. At this time, the students are in the same classroom, same dorm, and even are sharing the same room. The program manager And program director have been informed and nothing has been corrected. The direct care staff are trying their best to follow the orders but the management is not listening to the staff

Licensing Narrative:Received external anonymous complaint that doctor's orders were not being followed at the facility including two clients that were on a "6-foot order" due to sexual allegations. Facility visited 11/16/22. Licensing Specialist visited the facility from 2:00PM-4:00PM. Licensing Specialist visited the facility as a follow up to a complaint regarding staff not following doctor orders for safety plans on residents. The report states that two residents are on "six foot" due to sexual abuse allegations, but they continue to

share the same classroom, sleep on the same dorm, and share a bedroom together. The licensing specialist requested information on any resident who was on a safety plan on 11/4/22 or any resident currently on a safety plan and reviewed those plans. Clients [REDACTED] [REDACTED] and [REDACTED] on some level of precautions 11/4/22. All precaution orders for 11/4/22 viewed electronically. Clients [REDACTED] and [REDACTED] both on "SRB" (sexually related level B) precautions 11/4/22. Client [REDACTED] could not be interviewed today due to threatening behavior. The licensing specialist spoke to residents and discussed their safety plans, and the following was reported to the specialist. Client [REDACTED] interviewed whom stated the following: She was on 6-foot separation from client [REDACTED]. She did not share a bedroom with [REDACTED]. She was kept 6 ft away from [REDACTED] including the classroom and dorm, at all times. Video reviewed from the evening of 11/4/22 in Dorm 1 which shows [REDACTED] to be in a bedroom right before bedtime with roommate [REDACTED] not [REDACTED]. [REDACTED] could not be seen in Dorm 1 the evening of 11/4/22. Clients [REDACTED] [REDACTED] [REDACTED] (at acute) and [REDACTED] on some level of precautions today. Client [REDACTED] interviewed. Client [REDACTED] is a new admit and on line-of-sight precautions. Client [REDACTED] reported that staff are almost always watching her. Client states that staff are attentive to her needs and easily accessible. Client [REDACTED] interviewed whom stated he ([REDACTED] f/m who identifies as [REDACTED] male) was on bathroom precautions and self-harming contraband checks (order reviewed).
