While outside the resident began trying to fight staff. The resident was placed in a physical containment; while in the containment the resident is observed kicking, punching with closed fists, and head-butting multiple staff members. 3-4 staff members continuously attempted to contain the resident. While in the containment the resident continued to be resistant, the resident stated his wrist was injured during the containment. The resident was assessed by nursing and sent out to FCMC for further evaluation. **Actions Taken:** Resident was assessed by nursing and sent out to FCMC for an X-Ray. The resident was diagnosed [REDACTED]. Nursing will continue to monitor the residents' progress while in the milieu and in school. The resident has been placed on assault precautions and will be re-evaluated in the next 72 hours. **Guardianship:** [REDACTED]

Other staff members and a therapist were observed in view of the camera. Resident kicked at staff and was placed in a physical restraint. The ratio at that time of the restraint was 1:3 with a staff member observing. While in the physical restraint, resident was observed being physically aggressive toward staff by swinging, kicking, and head butting. When resident was released from the physical restraint, Licensing Specialist observed resident holding his wrist. Staff was not observed using inappropriate restraint techniques while the resident was in a physical restraint. Nursing tried to assess resident, but he refused treatment. He eventually allowed nursing to assess his wrist. No licensing concerns noted.

Licensing Specialist viewed camera footage for incidents that happened on 11/3/2022 () and 11/4/2022 ()

11/3/2022 – Licensing Specialist observed resident coming out of the gym and trying to climb the fence. Staff appeared to communicate with resident to come down off the fence. Resident kicked at staff but eventually got off the fence. It appeared that staff was communicating with the resident about his behavior of climbing the fence. Other staff members and a therapist were observed in view of the camera. Resident kicked at staff and was placed in a physical restraint. The ratio at that time of the restraint was 1:3 with a staff member observing. While in the physical restraint, resident was observed being physically aggressive toward staff by swinging, kicking, and head butting. When resident was released from the physical restraint, Licensing Specialist observed resident holding his wrist. Staff was not observed using inappropriate restraint techniques while the resident was in a physical restraint. Nursing tried to assess resident, but he refused treatment. He eventually allowed nursing to assess his wrist.

11/4/2022 – Licensing Specialist observed resident being upset to what appeared to be a room change. Staff was removing his belongings from a bedroom into the hall to another bedroom when the resident picked up his basket and dumped his belongings on the floor. Licensing Specialist was informed that resident was changing bedrooms due to an incident with a peer (bullying) and he refused to move his belongings. Resident appeared upset and got aggressive toward staff. Staff stood and observed resident while he vented and spat at staff. Other staff members arrived, and resident became more aggressive and was placed in a restraint. Resident was observed kicking, swinging, biting, and continued to spit at staff. Once calm, resident was released from the restraint and began to hit his head on the wall of the SRU hallway. He then walked by the door and began to hit, kick, and bang his head on the door. Staff was around the resident and appeared to be talking with him. Resident would start and stop his behaviors. Licensing Specialist observed resident banging his head, kicking, and hitting the metal door.

No licensing concerns noted.
