This peer came to staff to let her know pt. hurt herself on her pass with a razor blade she found in the trash at the hotel they were in with grandparents. Pt. had deep cuts in both of her thighs. Pt. stated she could not find herself safe. Nursing Assessment 11/24/22 @ 9:25 PM: Client returned from THV (therapeutic home visit). Client shows evidence of self harm, placed on front of house and eyeball status. Wound care provided and client to be sent to ACH to have wound evaluated. Client appeared distraught, shared emotions revolving around family relationships and self image. Encouraged client to use alternative coping skills that would benefit instead of damage the body. Encouraged client to be strong and stay safe. Given options of exercise writing, drawing and processing with staff when feeling the need to self harm. Client contracted for safety. Client spoke with family on the telephone. No other needs identified now, will continue to monitor. Client taken to ER at 11:00 PM Nursing Note 11/25/22 @ 3:42 AM: \*\* THIS IS NOT A RN FACE TO FACE\*\* Patient return from ER visit at 342am with new orders. Orders given to MD on call for approval. MD on call approved all orders and mother give consent for patient to take new medications. Patient return with 6 stitches to left lower extremity and right extremity was cleaned no stitches required. Patient currently on FOH and eyeball status. Patient voiced she was tired and need to rest. No further complaints or needs noted at this time Guardian notified 11/24/22 @ 11:04 PM
