## Narrative

On 04/03/2023, I was dispatched to Driller Dr in reference to a suspicious person. The caller said they could see a vehicle on their cameras that did not belong.d

When I arrived, I made contact with two females in the vehicle, one being Jazmyne Corley. She advised she was the night shift supervisor of Little Creek Behavioral Center. She said two juveniles ran away from their facility and they were in the area trying to locate them. Ms. Corley said the juveniles had been missing for approximately 30 minutes. She also said it was against their policy to only notify law enforcement 30 minutes after the juveniles were missing.

Narrative

I then went to Little Creek Behavioral Center to collect information on the missing juveniles. I immediately distributed the information and photos to communications as well as deputies searching in the area. Both juveniles are from out of state and only in Arkansas as a resident of Little Creek. They had no cell phones or family in the state. I was told the juveniles were in the gym area and found an open gate in the yard to leave the facility.

Deputies scoured the area along with staff from Little Creek but were unable to locate the juveniles. The juveniles were entered into NCIC with special attention to Conway Police Department and State Police.
