NARRATIVE

OFFICERS RESPONDED TO THIS LOCATION (METHODIST CHILDREN'S HOME) IN REFERENCE TO A DISTURBANCE IN PROGRESS. STAFF ADVISED THERE WAS A JUVENILE MALE ON SCENE DESTROYING PROPERTY AND MAKING THREATS TOWARDS STAFF MEMBERS. UPON ARRIVAL, OFFICERS MADE CONTACT WITH EMPLOYEE STEPHANIE MCCRAW. MS. MCCRAW STATED JUVENILE 1 (SUSPECT) ARRIVED AT THE FACILITY AROUND 1630 HOURS AND WAS IMMEDIATELY AGGRESSIVE AND HOSTILE WITH STAFF MEMBERS. MS. MCCRAW STATED WHEN THEY BEGAN THEIR MEDICAL ASSESSMENT ON JUV. 1, HE BEGAN TEARING UP PROPERTY IN THE LOBBY. MS. MCCRAW STATED SHE ADVISED ANOTHER STAFF MEMBER TO CALL THE POLICE, AND JUV. 1 THEN SLAPPED HER ACROSS THE FACE. OFFICERS DID NOT OBSERVE ANY MARKS TO MS. MCCRAW'S FACE WHILE ON SCENE. OFFICERS MADE CONTACT WITH JUV. 1 WHO CONTINUED TO BE HOSTILE TOWARDS OFFICERS AND MEMS. MS. MCCRAW REQUESTED JUV. 1 BE TAKEN TO CHILDREN'S HOSPITAL FOR ASSESSMENT AND REPLACEMENT. JUV. 1 WAS RESTRAINED BY MEMS STAFF DUE TO HIM ATTEMPTING TO KICK THE PARAMEDICS ON SCENE. HE WAS TAKEN TO CHILDREN'S HOSPITAL VIA MEMS WITHOUT INCIDENT WHERE HE RECIEVED MEDICAL ATTENTION. MS. MCCRAW WAS GIVEN AN INCIDENT NUMBER ON SCENE. MS. MCCRAW ADVISED THE FACILITY POSSIBLY HAD CAMERAS THAT CAPTURED THE INCIDENT AND OFFICERS ADVISED HER ON THE PROCESS OF SEEKING WARRANTS. MVR AND BWC IN USE.
