## Primary Narrative By Dylan Burke, 04/15/23 23:35

### Runaway Juvenile

On 4/15/2023 (Saturday), at approximately 2335 hours, I was dispatched to 20400 Colonel Glenn Road (Youth Home) in reference to a runaway juvenile. Dispatch advised that an [REDACTED] has not returned to the Youth Home. She was last seen at the Robinson High School Prom.

On arrival, I made contact with the complainant (Beauty Moore – Weekend caretaker at the Youth Home), who advised that [REDACTED] attended her high school prom and did not return back to the Youth Home. Beauty stated that the prom was being held at the Union Station located at 1400 W Markham in Little Rock and she was dropped off there at approximately 1900 hours by their staff and was supposed to be picked up 2300 hours on the date stated above. Beauty advised that the Youth Home attempted to contact [REDACTED] at her cell phone ([REDACTED]), but she was not answering. [REDACTED] did not take a date with her to the prom according to Beauty. [REDACTED] was wearing a red prom dress with glitter high heels. [REDACTED] had on a silver neckless and her finger nails were long with silver polish on them. She also has a butterfly tattoo on the right side of her neck. Beauty described [REDACTED] as a good kid who works at [REDACTED].

Beauty stated that [REDACTED] is senior this year and is under Department of Human Service custody. Beauty provided me with a face shot of [REDACTED] and a picture taken of her in her prom dress. The pictures were submitted to evidence. A Missing Person's form was completed.

When I contacted dispatch to enter [REDACTED] missing into ACIC/NCIC, I was advised by them that she would have to be entered into ACIC/NCIC by the Little Rock Police Department since she went missing in their jurisdiction. No NIC number was provided to me at that time.
