Narrative & Statements

Narrative - Gibson, Mallory - 4/27/2023 6:45:25 PM (Initial)

On April 27th, 2023, approximately 4:24p.m. I Officer M. Gibson 234 was dispatched to 600 North 7th Street, (Perimeter Behavioral Hospital) due to complaints of [REDACTED] (patient) hitting complainant Keith Williams.

Upon my arrival I made contact with the complainant, Keith Williams. Williams stated that this is an ongoing issue they are having with [REDACTED]. [REDACTED] has completed [REDACTED] program through Perimeter and is in DHS custody, Williams stated they have tried to contact Wanisha Fizer, who is Ward of State over [REDACTED] with no answer or calls in return. On today's date Williams was responding to assist other employees towards whom [REDACTED] was being verbally and physically aggressive. Once Williams got to [REDACTED] room he asked [REDACTED] multiple times to exit the restroom, which [REDACTED] denied and screamed "you know I don't fuck with you" and also stated that [REDACTED] was going to hit Williams in the face. Williams asked [REDACTED] not to hit him, but [REDACTED] shoved and hit him in the face at least 3 times. Williams attempted to contain [REDACTED] but due to him being alone [REDACTED] continued to attack him.

Williams advised that due to [REDACTED] being done with [REDACTED] assigned program through the state they have been attempting to contact DHS to come get [REDACTED] since [REDACTED] has been continuously violent towards employees. Due to the situation they are needing a report in order to force DHS to get [REDACTED]. Williams advised that they have already been in contact with juvenile officer Chip Barnes about the situation.
