I was dispatched on 5/1/23 at 0730 hours to Methodist Family Health in reference to a Juvenile hitting a staff member. Suspect 1 had hit Wazeunna Kimbrough in the face with a closed fist. I was also informed that he had done the same thing the day before (3/30/23) to Octavia Lloyd. We talked to suspect one about the incident. He said he was angry and didn't want to be there. We contacted Juvenile probation who said to let him stay there and not take him to jail.
