After verbal support and instructions to care for her hand, Pt began demanding juice, kicking the door and hitting the wall. Pt alternated between the front and the kitchen door and was unable to kick it open. Pt was yelling No as staff attempted to reason with her. Pt eventually headed to the emergency exit door and had to be restrained. 2:10pm Personal Restraint: Pt was placed in restraint at this time. Pt struggled with staff and was yelling let me go. Staff continued to offer verbal support. Pt complained of pain on her hand. Pt responded well to staff's verbal de-escalation and began to relax and stopped struggling. 2:15pm Personal Restraint End: Pt was visibly calm. Nurse explained to Pt that we need to assure she was safe in order to assess her hand. Pt allowed the nurse to assess her hand. Pt was released at this time. Patient Debriefing date/time: 03/15/2023 3:15pm: Time was spent validating the Pt feelings. Pt understood the possible dangers that could occur if she was allowed to leave the premises without consent. Staff discussed what was causing her verbal and physical aggression and ways she could cope with it in a positive manner. UM Debriefing date/time: 03/15/23 3:00pm Injuries to client: Right hand 3rd-5th digit knuckles noted to be bruised and swollen. Limited ROM with mild/moderate pain. Follow-up to injury: Client sent to Arkansas Children's Hospital Nursing Assessment date/time: 03/15/2023 2:20pm: Came to Mabee house to assess right hand injury. Client having changes in mood and behavior.

Client demanding to go out the front door. Client was encouraged to calm down. Client feeding off peer limit peer. Client began kicking the front door and hitting the wall with her right hand. Client then ran to restricted area and personal restraint was initiated.

Encouraged client to relax, refused and continued to struggle with staff. Client was able to calm down and was released from restraint. Encouraged client to take good care of her hands because she will have them for life. Right hand 3-5th digit knuckles noted to be bruised and swollen. Limited ROM with mild/moderate pain, complains of numbness to 5th digit, capillary refill >3 seconds. Client not stable enough to go to urgent care with single staff supervision. Client shared that she wanted to kill herself. Encouraged client to make good choices, to give her future self a chance. Client voiced suicidal ideation once again, and the call was made to transfer to acute. Will continue to monitor. Client left for ACH ER, possible transfer to acute from there. Guardian was contacted by nurse on 03/15/23 at 2:54pm and 2:56pm: Guardian informed of need for emergency room prior to acute admission for treatment/evaluation of right hand injury.

Interim Action Narrative: Resident was assessed by nursing and transferred to AR Children's Hospital emergency room for further evaluation. Due to resident's voicing suicidal ideation she was admitted to acute care after evaluation.

Licensing Specialist reviewed camera footage for a provider reported incident.

Licensing Specialist observed and heard resident communicating with staff, ratio 2:2. Residents and staff were in the day area. The two residents were at Mabee House due to not being able to attend school.

Licensing Specialist observed resident kicking the kitchen door and the front entrance door. Resident was also observed throwing a chair and attempting to be destructive. Licensing Specialist observed resident running from staff down a hallway where the residents' bedrooms are located. Staff (ratio 2:1) followed behind resident and she was restrained.

Other staff arrived to Mabee House, ratio 5:1, to assist with the restraint. Licensing Specialist did not observe resident injuring her hand. Licensing Specialist did hear resident being verbally aggressive toward staff. Once released from being restrained, Licensing Specialist observed resident get off the floor and walk to the day area where she was observed talking with staff.

Mr. Pulliam informed Licensing Specialist that that resident is scheduled to be discharged from Methodist Acute Care on 3/21/2023.
