**Report Description: Per staff, [REDACTED], attempted to elope from the facility by climbing the fence. While trying to climb the fence the resident received a puncture hole in each palm of hand from the top of fence. Staff immediately intervened and resident was unsuccessful. Resident was immediately taken to nursing and assessed. A referral was made by the APRN to sent the resident out to FCMC for further assessment. The resident was diagnosed with a [REDACTED]. The resident was placed on elopement precautions and unit restrictions for the next 72 hours (about 3 days). Those precautions will be reassessed for safety. All proper notifications were made, and nursing will continue to monitor the resident's progress while in the milieu and school.**

**Interim Action Narrative: Resident was assessed by nursing and referred by the APRN to FCMC for further evaluation. Resident placed on elopement precautions and unit restriction.**
