Description:

On March 28, 2023 at approximately 6:18pm I answered a citizen assist phone call and spoke with a Sara Kroon(W/F DOB: 9/23/94) she explained that she is a nurse at Perimeter of the Ozarks trauma facility at 2466 S 48th St B as was assaulted by a resident earlier today. Kroon explained that she was working when she noticed that a resident identified as [REDACTED] was banging on a door requesting her belongings and banging on a door when she confronted her and told her to stop, the [REDACTED] then became agitated and began to attack Kroon with the hairbrush and also punching her in the face. Kroon stated that she was able to get away she then called the police to file a report. I advised Kroon to take pictures of her injuries and send them to my PD email as she explained she had visible marks on her. Kroon explained that [REDACTED] is a resident of the facility and the only legal guardian she has is DHS. She provided me with the contact info for her case worker as Ghazal.Doraji@DHS.AR.GOV. I have not received any images from the victim at this time. It should be noted that the suspect will be dismissed from the facility in two days for the assault. No further at this time.

On 4/18/23 I made contact with the victim, [REDACTED] and asked her if she had any further contact with [REDACTED]. [REDACTED] stated after the incident [REDACTED] was removed from the facility and taken to another behavioral facility. I asked [REDACTED] if she still wanted to press charges against [REDACTED]. [REDACTED] stated [REDACTED] has struck several employees in the past and she doesn't learn her lesson because no one presses charges. [REDACTED] stated she will be pursuing charges against [REDACTED].

[REDACTED] stated the state of Arkansas has custody of [REDACTED] and I would need to make contact with the case worker. I asked [REDACTED] if she still had the pictures of the bruises she sustained when [REDACTED] struck her. [REDACTED] stated she does and will be sending me the pictures via email.

I attempted to call the case worker assigned to [REDACTED] and I was unable to make contact with them. I emailed the case worker my information to give me call.

As of 5/4/23 I have not received any pictures from [REDACTED]. I made contact with her and asked the status of the pictures. [REDACTED] stated she forgot and would be sending the pictures soon.

As of 5/12/23 I have not received any pictures from [REDACTED] and I have not received a call back from a case worker in charge of [REDACTED]. I called [REDACTED] to ask about the pictures, but she did not answer. I left a voicemail requesting a call back.

Description:

I have attempted multiple times to gather the pictures of injuries [REDACTED] had sustained when she was struck by [REDACTED]. [REDACTED] has not been able to send me the pictures or return my call. I have attempted to get in touch with the DHS case worker in charge of [REDACTED]. I have called the number, left voice mails, and emailed them with no response. It was my understanding [REDACTED] was moved to a different behavioral health facility in the state. At this time due to the victim not cooperating by sending me the evidence of the crime, I will be placing this case as inactive pending further leads. I will be forwarding this case to my supervisor for review.
