Notice of Serious Incident

Report Description: On 3/29/2023, at 701 a.m., [REDACTED], DHS placement client, walked on the hallway where [REDACTED] (staff) were sitting on the hallway monitoring other clients. [REDACTED] walked over to one side of [REDACTED] chair looking for her walkie talkie, then he went to the other side of [REDACTED] and plucked her in the head. [REDACTED] stands up, stating to [REDACTED] "boy leave me alone". [REDACTED] reaches up to pluck [REDACTED] again and she reacted quickly by yelling stop and hitting [REDACTED] in the face with the clipboard. [REDACTED] then continue to walk toward [REDACTED] she extended her arm to keep him away from her by using a little push. [REDACTED] reported that she accidentally hit [REDACTED] with the clipboard while trying to prevent him from plucking her. A [REDACTED] report was completed and the report was only documented and awaiting review from a supervisor to determine if the report will be accepted or not. The [REDACTED] referral number is [REDACTED] Corrective action plan: [REDACTED] was suspended immediately due to pending investigation.

Maltreatment Narrative: We accepted a report involving a foster child? [REDACTED] The listed ?caregiver? is [REDACTED] but quite possibly the reporter meant [REDACTED] [REDACTED] Supv. Av is [REDACTED]. He is currently in DHS custody, and his PRFC is [REDACTED] Out of home offender

is [REDACTED] who is an employee of Methodist Family Children's Home in Little Rock, Ar. [REDACTED] is currently residing at the facility and has been since January 6, 2023. Reportedly, [REDACTED] was sitting in the hallway when [REDACTED] came out of his room looking for her walkie-talkie. He then asked her where it was and proceeded to "pluck" her in the head with his finger. It was disclosed that she told him to stop, and he attempted to "pluck" her on the shoulder. However, [REDACTED] reacted and swatted at him hitting him in the face with her clipboard. It was not believed that [REDACTED]'s actions were intentional and suggested that it seemed like she forgot the clipboard was in her hand. [REDACTED]'s nose did bleed after being hit in the face, but he did not require outside care.
