She was noted to have two bite marks on her left arm and three on her right arm. None of which have broken any skin. Resident will be placed on self-harm precautions with constant line of sight. Clinical will determine the appropriate length of time this precaution will be in place and individualize as needed. No nursing care needed to be rendered.

Interim Action Narrative: Resident was assessed by the nurse. No broken skin noted. Resident placed on self-harm precautions and constant line of sight.
