Staff attempted to verbally de-escalate and physically block residents attempts at harming themselves but were unable to. Due to the immediate threat for bodily injury, a physical hold was initiated. When resident was able to emotionally regulate and verbalize that they will maintain safe behaviors, they were transitioned out of the hold. Per RN report, no injuries were sustained from this event. Resident placed on a self-harm precaution safety plan with constant line of sight. Therapist will meet with resident to discuss duration/individualization of safety plan.

Interim Action Narrative: Resident was placed in a physical hold for safety. She was assessed by the nurse. Resident was placed on self-harm precautions and constant line of sight.

Licensing Specialist reviewed camera footage for a provider reported incident on 4/2/2023.

Licensing Specialist observed resident walk down the hall of the Green Unit. Resident was observed moving from side to side of the hallway. Licensing Specialist was unable to observed resident hitting her head due to the angle of the camera.

Resident was escorted off the Green Unit hallway, ratio 2:1, and taken to the seclusion room. While in the seclusion room, resident was observed moving around the room attempted to hit her head on the walls. Staff intervened by blocking resident from hitting her head with their arms as she moved around the room, ratio 4:1.

Minutes later, resident was placed in a restraint, ratio 3:1, and a pillow was placed under her head for safety. Resident was placed in a restraint for 23 minutes until she was able to calm down. Once she calmed down, Licensing Specialist observed resident processing with staff, ratio 2:1.

Ms. Sara Kroon (Director of Nursing) informed Licensing Specialist that resident is no longer on safety precautions.
