The allegation of resident being touched at the house happened on 3/31/2023 when the residents had to take shelter because of the tornado. The allegation of being touched while on an outing, there are no cameras on the vans.

Mr. White informed Licensing Specialist that the residents are on Peer Limit Precaution. Residents are to stay six (6) feet apart, no contact, and no communication with one another.

Licensing Specialist is not prepared to leave a finding at this time.
