Program Manager Litzsey viewed video footage of the incident. Video footage showed clients eating breakfast. There were 2 staff present with the clients as they ate breakfast. A/V can be seen in getting up in A/O's face/ personal space and evening touching the A/O. A/V can be seen going up to other clients trying to get their food. Staff redirect A/V and he eventually sits down. As the video goes on, the clients move across the hall to dayroom area with 2 staff. Clients are running around and eventually get into the pantry area take out snacks and pass them out. A/V and A/O have a struggle outside of the view of the camera in a corner by the day room. Clients can be seen running up and down the hall with staff present. A third staff comes and attempts to calm the clients down. A/V can be seen attempting to push past staff 3, A/O comes out and tries to help. A/V pushes A/O, A/O raises his arm to protect himself (never in a motion to hit A/V).
