Actions Taken: The resident was taken to the nurse's station and assessed. The resident was then assessed by the APRN. The APRN referred the resident to FCMC for further evaluation. The resident was diagnosed with: [REDACTED]. The resident has been restricted from his peer. The resident was also placed on assault precautions which will be re-evaluated within 72 hours (about 3 days) for safety. All appropriate notifications have been made. Interim Action Narrative: Resident was assessed by nursing and referred to FCMC for further evaluation. He was placed on peer restriction and assault precautions.

Program Coordinator visited the facility and discussed the incident that occurred with resident [REDACTED] on 4/23/2023.

Video review from 4/23/23 from 9:20am- Residents from station 1 unit hallway. The resident had been out of area (in the cafeteria) after he kicked the door open and was directed back to his unit. Once back on the unit the resident is in his bedroom when at 9:25 a fight appears to have occurred inside the bedroom. It cannot be seen on video, but staff quickly enter the room. The resident is removed from the bedroom in a restraint hold to calm down in the hallway. The resident had been aggressive and non-compliant with staff and peers throughout the day and entered his peer's bedroom against the rules.

A copy of the ESI packet was received from the facility, along with the nursing body check, restraint order, and a medical screening exam.
